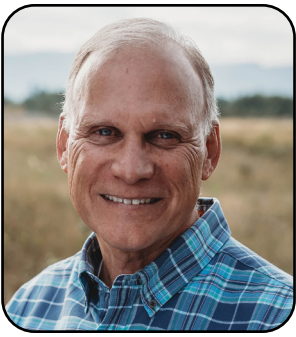

20 If someone says, "I love God," and hates his brother, he is a liar; for he who does not love his brother whom he has seen, how can he love God whom he has not seen? 21 And this commandment we have from Him: that he who loves God must love his brother also.

As we begin 2022 may we each be examples of love to all in whom we come in contact and thus fulfill our high calling as children of the King!

Prayer, work and time prove powerful combination on mission field

Prayer, individual work and teamwork with local or U.S. churches are important for effectiveness in the mission to reach souls for Christ. Many are involved in mission work, not by their physical presence on the field, but by prayer that sustains those on the field. Sometimes, a sower becomes discouraged at not seeing fruit or tangible results in their work.

However, with prayer and time, for God nothing is impossible.

IMB missionary Stan Meador knows how valuable this combination of prayer, work and time is. Two years ago, he asked some churches from the U.S. to support him in prayer for the work he was doing in collaboration with a Brazilian church. The pastor of the church had contacted Stan, requesting help training leaders. One of the initiatives they started was a training in how to lead evangelistic Bible studies.

But soon COVID-19 changed their plans.

Despite the restrictions caused by the outbreak of the pandemic in March 2020, the training of leaders continued virtually through messaging apps. About a dozen people continued the training in this format.

Meador sent the group Bible stories to study and questions to answer about the text. Each person sent their answers back, individually, through the app. He responded with encouraging comments and his own answers.

The first time Marta, a former Catholic turned evangelical, sent Meador her answers, she asked him to correct her mistakes. He couldn't find any and responded, encouraging her to keep studying. This pattern continued.

Studying the Bible virtually revealed something to Meador that would not have been possible to observe in an in-person study: Marta doubted her ability to understand the Bible.

Her Catholic background taught her that it wasn't possible for her to understand the Bible on her own; she thought she needed the help of a priest to explain Scripture. Although she had been an evangelical Christian for many years, nobody had ever taught her that it was possible to understand the Bible without the help of a religious professional. Through this experience, her perspective changed. By going through the Bible studies with Meador, Marta was finally understanding that it was possible to study the Bible for herself.

Marta was also learning that the purpose of being a disciple

of Christ went beyond the ability to personally understand the Bible with the help of the Spirit of God. Disciples are meant to share what they learn and make more disciples. The question found at the end of each Bible study illustrates this principle well: "With whom can you share this story?"

During COVID lockdowns, this group found unique ways to share the gospel. Bible study participants, with Meador's guidance, were able to start their own virtual Bible study groups. And Marta, although she did not form a virtual group, was able to start sharing the Bible stories with her husband, Lucas*, who was Catholic.

Marta had been praying for Lucas and sharing her faith with him for years. The most fruit she'd seen from her labor and prayer was him occasionally attending her Baptist church with her. Still, she never stopped praying for him.

Every night she would go to their room to pray. Sometimes she invited him to join her and, not to hurt her feelings, he accepted her invitation, sitting on the bed while his wife prayed.

As Marta and her husband continued to study the Bible, he began to realize it was possible to understand it. One of those many prayer-filled nights that Marta was in her room, Lucas decided to follow her, this time voluntarily praying on his knees together with her.

Meador and his wife, Wendy, were in the U.S. for a little over a year during this time. When they returned to Brazil, they

learned the church they were working with was going to baptize six people.

Lucas was one of the six.

"Rejoice with us," are the words Stan used to conclude this

story — a story of victory that inspires us to persist in prayer and in the work God has called us to do. Whether it be working on the mission field or supporting a missionary in prayer for his work, our prayers are heard and answered.

For Meador, it took thirteen months to see the result of one more soul transformed, but for Marta, it took far longer than months. It took decades to see the salvation of her husband.

We may not know how long it will take before we gather the fruits of our labor, but we do know that the time to sow and to pray is now. Let us never stop kneeling in prayer, nor stop being faithful where God has placed us, because our labor in the Lord, as the lives of Marta and Stan demonstrate, will never be in vain.

January is "Plan Your Estate Month"

So how does property transfer at death?

This is an often-misunderstood area in the law. Many people believe that all assets of real and personal property are passed using the Last Will and Testament (Will). This is not the case. There are three broad ways by which property ownership is transferred:

- 1. Operation of Law**-such as joint ownership with right of survivorship, or property deed.
- 2. Contract**-such as a beneficiary designation on retirement accounts, or life insurance. Property transferred by a "Trust" is a form of contract.
- 3. Probate**-such as a Will or intestate (without a Will) by the laws of distribution of the state. Essentially, any property not passing by either contract or operation of law.

As shown above, the provisions of a Will are superseded by assets that transfer by operation of law or contract, in cases where a conflict exists, such as a Will, indicating that an IRA or certain real estate will be distributed equally among siblings. To the extent that a beneficiary has been named by contract, in the case of a retirement account or named by deed in the case of real estate, the provisions of the Will are nullified.

You may hear a discussion about having a "Will" or a "Revocable Living Trust" (RLT). Is one superior over the other?

In true legal fashion, the answer is typically: "it depends." Certainly, RLT has the benefit of avoiding probate. Privacy can be maintained and assets transferred quickly. One of the biggest benefits of the RLT is the ability to hold multiple real estate items, even in different states. This can be of tremendous benefit in that multiple probate proceedings do not have to occur for each parcel of real estate on a state-by-state basis.

The principal drawback of an RLT is the expense. They are more complicated and generally require more legal expertise to implement appropriately.

A relatively recent option, however, has become more widely available, including in Alaska. This is the "Transfer of Death-Deed" (TODD) which is essentially a way to transfer an ownership interest in real estate at death. The TODD allows the principal owner of real estate to maintain full legal title, and then only after death does the real estate transfer, in part or whole, to the designated beneficiaries. Since this document is a deed, it transfers as an operation of law and therefore avoids probate. The process is much easier to set up and does not generally require any formal name changes to the ownership of the real estate as with an RLT. If an individual owns multiple real properties in different states and as long as each state involved has (TODD) options, individuals may be able to receive one of the biggest advantages of an RLT at a fraction of the expense.

The main point is the importance of making some effort to plan for the estate which the Lord has entrusted each of us. While the RLT can be a wonderful tool, it is by no means the only option. Regardless of what combination individuals choose to entitle ownership of assets, the Will must always be at the heart of any good estate plan, even if it only serves in a "pour over" capacity to an RLT or some other trust instrument.

Mighty Is He Craig, Alaska

Liberty Church in Craig has been very busy over the last six months. The arrival of mission teams from Alabama, helped to create an atmosphere of giving and outreach. While many of the teams worked on finishing different parts of the church building, there was also a focused outreach to the community. Two different VBS programs were held, reaching about 36 children. Sunday School leaders were helped with creating a plan for teaching the youth. The great news is that, once our friends from Alabama went home, outreach has continued to be a major focus of Liberty Church.

Here are just a few of the outreach programs that are happening:

Friday Night Fun—youth from fifth grade to age 17 meet at the church for activities such as movies, dinner, and games. Since September there have been five events, each reaching between 5 to 20 youth.

The youth have also been learning about service. Service activities included trash pickup around the church after Sunday service. They also gave up a day of sledding to serve hot cocoa to others at the sledding hill. This was during one of the first snowfalls of the year with enough snow to actually go sledding.

Backpack Give Away—160 backpacks filled with school supplies were given out to anyone who filled out a form with contact information. There were no income restrictions. If you needed a backpack you got one.

Thanksgiving Food Boxes—a complete dinner of ham or turkey with all the fixings: potatoes, gravy, stuffing, green beans, rolls, butter and, of course, cranberries. Church members signed up to purchase the fixings. The Autauga Baptist Association sent money to purchase the hams and turkeys.

Hats & Hot Cocoa—the Christians in Alabama who enjoy hand-crafts, knitted hats and scarfs. These were handed out on a Saturday in early December to about 30 people who stopped by the church to enjoy a cup of hot cocoa.

December 18 was the Gifts for Kids Giveaway. Alaska Power & Telephone generously donated funds which helped Liberty Church to purchase about 300 gifts for ages 0 to 17.
