A Missional Strategy

I will never forget the impact the film, *The Mission*, had on me when I was preparing for overseas mission service. The film which came out in 1986, portrayed a Spanish Jesuit priest named Father Gabriel who went to South America to take the gospel to a remote tribe of unreached people called the Guarani. The task was hard, and progress was hampered by misunderstandings of culture and language. So many mistakes were made. It was only by the grace of God that Father Gabriel was successful in establishing the mission.

Taking the gospel to places that have never been evangelized requires a well-perceived missional strategy. Several elements must be considered before one is able to share the gospel or plant a church. Jesus often used parables with an agricultural context to describe Kingdom growth. The four-fields illustration used by many IMB missionaries helps to identify the process of missional engagement.

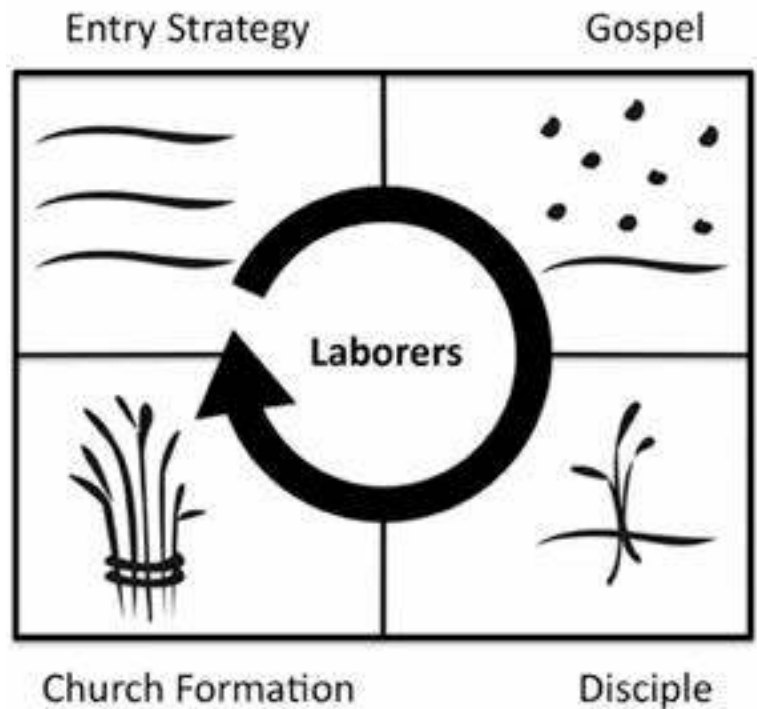
- Field 1: GOING – The farmer enters the empty field and prepares it to receive the seed;
 - Field 2: SOWING – The farmer casts the seed faithfully not knowing where it may grow best;
 - Field 3: GROWING – The farmer nurtures the seeds that take root for an eventual harvest;
 - Field 4: GATHERING – When the field is ripe, the farmer gathers the crop to the storehouse.

It is important to recognize that gathering can only happen AFTER the farmer has entered the field, planted the seeds, and nurtured them to full fruition. Unfortunately, I have seen harvesters get these elements out of order. The popular film *Field of Dreams* espoused a strategy that many have bought into that says, “If you build it, they will come!” The farmer knows that if you build a barn but don’t do anything else, you will always have an empty barn.

Church planting is an important element of missional engagement, but it isn’t the only element. Missions involves going and building bridges and removing barriers that hinder the

gospel. It means learning how to successfully sow seeds in unique soil. It requires constant attention to building and nurturing relationships that hopefully will lead to gathering disciples into a group, a church. It is a process that cannot be altered.

We have received the Great Commission to join God in the harvest of souls. May we be found faithful in going, sowing, growing and gathering that the Kingdom of God may spread across Alaska to His honor and glory.

Commend others to God and the word of His grace

Provide for yourself and those around you

Support the weak

Remember the words of the Lord Jesus “It is more blessed to give than to receive”

Article VI Meetings

Remove existing sections of Article VI Meetings and replace with:

CURRENT LANGUAGE	PROPOSED LANGUAGE
SECTION 1. The Convention shall meet annually; the dates and places of the annual sessions are to be approved by the Convention. SECTION 2. Special meetings of the Convention shall be called by the Convention in session or the Executive Board according to the Constitution and Bylaws of the Convention.	Regular and special meetings of the Alaska Baptist Convention and all associated committees shall occur as set forth in the Constitution and Bylaws of the Alaska Baptist Convention.

The annual meeting of the Convention and all associated committees shall be conducted with messengers physically present in a single room or area giving opportunity for simultaneous aural communication among all participants. These meetings may be conducted electronically, or in a hybrid (having both in-person and electronic attendees) manner when (a) the President or First Vice-President has obtained written consent for this from a majority of the Executive Board members; (b) when so directed by the Board; or (c) in the case of special meetings, when so directed by those calling the special meeting. Electronic meetings shall be conducted through use of Internet meeting services designated by the President that support anonymous voting and support visible displays identifying those participating, identifying those seeking recognition to speak, showing (or permitting the retrieval of) the text of pending motions, and showing the results of votes. These electronic meetings of the Convention and its committees shall be subject to all rules adopted by the Convention to govern them, which may include any reasonable limitation on, and requirements for, Messenger participation. Any such rules adopted by the Convention shall supersede any conflicting rules in the parliamentary authority, but may not otherwise conflict with or alter any rule or decision of the Convention. An anonymous vote conducted through the designated Internet meeting service or online survey tool shall be deemed a ballot vote, fulfilling any requirement in the bylaws or rules that a vote be conducted by ballot.

Article II Meetings
Section 2

The Annual Convention and all associated committees of the Alaska Baptist Convention shall be conducted with messengers physically present in a single room or area giving opportunity for simultaneous aural communication among all participants. These meetings may be conducted electronically, or in a hybrid (having both in-person and electronic attendees) manner when (a) the President or First Vice-President has obtained written consent for this from a majority of the Executive Board members; (b) when so directed by the Board; or (c) in the case of special meetings, when so directed by those calling the special meeting. Electronic meetings shall be conducted through use of Internet meeting services designated by the President that support anonymous voting and support visible displays identifying those participating, identifying those seeking recognition to speak, showing (or permitting the retrieval of) the text of pending motions, and showing the results of votes. These electronic meetings of the Convention or its committees shall be subject to all rules adopted by the Convention to govern them, which may include any reasonable limitation on, and requirements for, Messenger participation. Any such rules adopted by the Convention shall supersede any conflicting rules in the parliamentary authority, but may not otherwise conflict with or alter any rule or decision of the Convention. An anonymous vote conducted through the designated Internet meeting service or online survey tool shall be deemed a ballot vote, fulfilling any requirement in the bylaws or rules that a vote be conducted by ballot.

**In Article VI, to insert after Section 20
a new Section 21 reading as follows:**

ALASKA BAPTIST CONVENTION BYLAWS

Article VI Executive Board
Section 21

Meetings of the Executive Board and all associated committees shall be conducted with board members physically present in a single room or area giving opportunity for simultaneous aural communication among all participants. These meetings may be conducted electronically, or in a hybrid (having both in-person and electronic attendees) manner when (a) the President or First Vice-President has obtained written consent for this from a majority of the Board members; (b) when so directed by the Board; or (c) in the case of special meetings, when so directed by those calling the special meeting. Electronic meetings shall be conducted through use of Internet meeting services designated by the President that support anonymous voting and support visible displays identifying those participating, identifying those seeking recognition to speak, showing (or permitting the retrieval of) the text of pending motions, and showing the results of votes. These electronic meetings of the Board or its committees shall be subject to all rules adopted by the Board, or by the Convention, to govern them, which may include any reasonable limitation on, and requirements for, Director participation. Any such rules adopted by the Board shall supersede any conflicting rules in the parliamentary authority, but may not otherwise conflict with or alter any rule or decision of the Convention. An anonymous vote conducted through the designated Internet meeting service or online survey tool shall be deemed a ballot vote, fulfilling any requirement in the bylaws or rules that a vote be conducted by ballot.

Article IV Board of Directors

Meetings of the Board of Directors and its committees shall be conducted with directors physically present in a single room or area giving opportunity for simultaneous aural communication among all participants. These meetings may be conducted electronically, or in a hybrid (having both in-person and electronic attendees) manner when (a) the President or First Vice-President has obtained written consent for this from a majority of the Board members; (b) when so directed by the Board; or (c) in the case of special meetings, when so directed by those calling the special meeting. Electronic meetings shall be conducted through use of Internet meeting services designated by the President that support anonymous voting and support visible displays identifying those participating, identifying those seeking recognition to speak, showing (or permitting the retrieval of) the text of pending motions, and showing the results of votes. These electronic meetings of the Board or its committees shall be subject to all rules adopted by the Board, or by the Convention, to govern them, which may include any reasonable limitation on, and requirements for, Director participation. Any such rules adopted by the Board shall supersede any conflicting rules in the parliamentary authority, but may not otherwise conflict with or alter any rule or decision of the Convention. An anonymous vote conducted through the designated Internet meeting service or online survey tool shall be deemed a ballot vote, fulfilling any requirement in the bylaws or rules that a vote be conducted by ballot.

**In Article II, to insert after Section 1
a new Section 2 reading as follows:**

ALASKA BAPTIST FAMILY SERVICES BYLAWS

Article IX Meetings
Section 2

Meetings of the Board of Directors or its committees shall be conducted with directors physically present in a single room or area giving opportunity for simultaneous aural communication among all participants. These meetings may be conducted electronically, or in a hybrid (having both in-person and electronic attendees) manner when (a) the President or First Vice-President has obtained written consent for this from a majority of the Board members; (b) when so directed by the Board; or (c) in the case of special meetings, when so directed by those calling the special meeting. Electronic meetings shall be conducted through use of Internet meeting services designated by the President that support anonymous voting and support visible displays identifying those participating, identifying those seeking recognition to speak, showing (or permitting the retrieval of) the text of pending motions, and showing the results of votes. These electronic meetings of the Board or its committees shall be subject to all rules adopted by the Board, or by the Convention, to govern them, which may include any reasonable limitation on, and requirements for, Director participation. Any such rules adopted by the Board shall supersede any conflicting rules in the parliamentary authority, but may not otherwise conflict with or alter any rule or decision of the Convention. An anonymous vote conducted through the designated Internet meeting service or online survey tool shall be deemed a ballot vote, fulfilling any requirement in the bylaws or rules that a vote be conducted by ballot.

Additions to Policies and Procedures of the Alaska Baptist Convention

Rationale: Rules need to be adopted for electronic meetings. They will be voted on as additions to the Policies and Procedures (which are our standing rules) as soon as the electronic portion of the meeting is up and running.

RULES FOR ELECTRONIC MEETINGS ANNUAL MEETING OF THE ALASKA BAPTIST CONVENTION AND ITS COMMITTEES

- 1. Login information.** The Recording Secretary shall send by email to every messenger, at least three (3) days before each meeting, the time of the meeting, the URL and codes necessary to connect to the Internet meeting service, and, as alternative and backup to the audio connecting included within the Internet service, the phone number and access codes the messenger needs to participate aurally by telephone. The Recording Secretary shall also include a copy of, or a link to, these rules.
- 2. Login time.** The Recording Secretary, or his or her designated assistant, shall schedule Internet meeting service availability to begin at least 15 minutes before the start of each meeting.
- 3. Signing in and out.** Messengers shall identify themselves as required to sign in to the Internet meeting service, and shall maintain Internet and audio access throughout the meeting whenever present, but shall sign out upon any departure before adjournment.
- 4. Quorum Calls.** The presence of a quorum shall be established by the online list of participating messengers at the beginning of the meeting. Thereafter, the continued presence of a quorum shall be determined in the same manner, unless any messenger demands a quorum count by audible roll call. Such a demand may be made following any vote for which the announced totals add to less than a quorum.
- 5. Technical requirements and malfunction.** Each messenger is responsible for his or her audio and Internet connection; no action shall be invalidated on the grounds that the loss of, or poor quality of, a messenger's individual connection prevented participation in the meeting.
- 6. Forced disconnections.** The chair may cause or direct the disconnection or muting of a messenger's connection if it is causing undue interference with the meeting. The chair's decision to do so, which is subject to an undebatable appeal that can be made by any messenger, shall be announced during the meeting and recorded in the minutes.
- 7. Assignment of the floor.** To seek recognition by the chair, a messenger shall [specifying the exact method appropriate to the Internet meeting service being used]. Upon assigning the floor to a messenger, the chair, or his or her designated assistant, shall clear the online que of messengers who had been seeking recognition. To claim preference in recognition, another messenger who had been seeking recognition may promptly seek recognition again, and the chair shall recognize the messenger for the limited purpose of determining whether that messenger is entitled to preference in recognitions.
- 8. Interrupting a messenger.** A messenger who intends to make a motion or request that under the rules may interrupt a speaker shall use [the designated feature] for so indicating, and shall thereafter wait a reasonable time for the chair's instructions before attempting to interrupt the speaker by voice.
- 9. Motions submitted in writing.** A messenger intending to make a main motion, to offer an amendment, or to propose instructions to a committee, shall, before or after being recognized, post the motion in writing to the online area designated by the Recording Secretary for this purpose, preceded by the messenger's name and a number corresponding to how many written motions the messenger has so far posted during the meeting (e.g., "SMITH 3:"; "FRANCES JONES 2:"). Use of the online area designated by the Recording Secretary for this purpose shall be restricted to posting the text of intended motions.
- 10. Display of motions.** The Recording Secretary shall designate an online area exclusively for the display of the immediately pending question and other relevant pending questions (such as the main motion, or the pertinent part of the main motion, when an amendment to it is immediately pending); and, to the extent feasible, the Recording Secretary, or any assistants appointed by him or her for this purpose, shall cause such questions, or any other documents that are currently before the meeting for action or information, to be displayed therein until disposed of.
- 11. Voting.** Votes shall be taken by the anonymous voting feature of the Internet meeting service, unless a different method is ordered by the Convention or required by the rules. When required or ordered, the other permissible methods of voting are by electronic roll call or by audible roll call. The chair's announcement of the voting result shall include the number of messengers voting on each side of the question and the number, if any, who explicitly respond to acknowledge their presence without casting a vote. Business may also be conducted by unanimous consent.
- 12. Video Display.** [For groups using video, but in which the number of participants is too large for all to be displayed simultaneously:] The chair, the Recording Secretary, or their assistants shall cause a video of the chair to be displayed throughout the meeting, and shall also cause display of the video of the messenger currently recognized to speak or report.

Additions to Policies and Procedures of the Alaska Baptist Convention (comt.)

RULES FOR ELECTRONIC MEETINGS BOARDS AND THEIR COMMITTEES ABC, ABF, ABFS

1. **Login information.** The Recording Secretary shall send by email to every member of the Board, at least three (3) days before each meeting, the time of the meeting, the URL and codes necessary to connect to the Internet meeting service, and, as alternative and backup to the audio connecting included within the Internet service, the phone number and access codes the member needs to participate aurally by telephone. The Recording Secretary shall also include a copy of, or a link to, these rules.
2. **Login time.** The Recording Secretary, or his or her designated assistant, shall schedule Internet meeting service availability to begin at least 15 minutes before the start of each meeting.
3. **Technical requirements.** For the purposes of electronic ballot voting and file sharing, members shall maintain Internet access during the meeting.
4. **Arrival announcements.** Members shall announce themselves at the first opportunity after joining the electronic meeting, but may not interrupt a speaker to do so.
5. **Departure announcements.** Members who leave the electronic meeting before adjournment shall announce their departure, but may not interrupt a speaker to do so.
6. **Quorum Calls.** The presence of a quorum shall be established by audible roll call at the beginning of the meeting. Thereafter, the continued presence of a quorum shall be determined in the same manner, unless any member demands a quorum count by audible roll call. Such a demand may be made following any vote for which the announced totals add to less than a quorum.
7. **Obtaining the floor.** To seek recognition by the chair, a member shall address the chair and state his or her own name.
8. **Motions submitted in writing.** Members may submit motions to the chair in writing by uploading them to the file-hosting service and notifying the chair of the URL or download link needed to access the file.
9. **Voting.** All votes shall be taken by roll call, unless required under the rules or ordered by the Board to be taken by ballot. When a vote is taken by roll call, only the number of votes on each side and the number of members present but not voting shall be entered in the minutes, unless the Board orders a fully recorded roll-call vote. Ballot votes shall be taken electronically, as follows: The Recording Secretary shall post the question using the online survey tool, and the chair shall then alert the members that the polls are open, providing any additional information that members need to cast their votes online. The polls shall be closed not less than two minutes after they have been opened by the chair. Business may also be conducted by unanimous consent.
10. **Technical malfunctions.** Each member is responsible for his or her audio and Internet connection; no action shall be

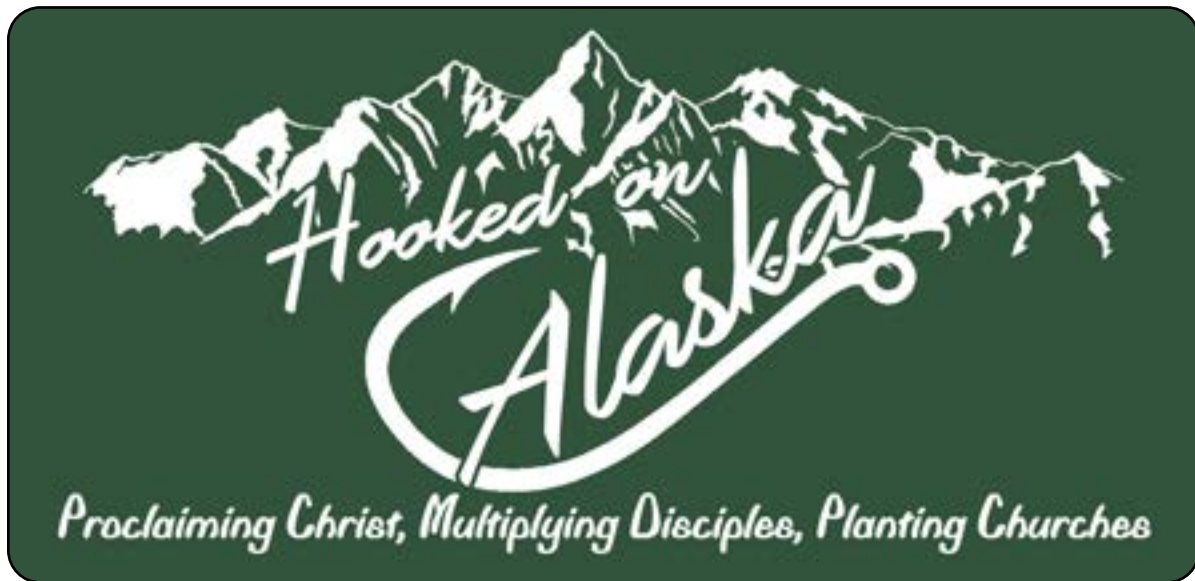
invalidated on the grounds that the loss of, or poor quality of, a member's individual connection prevented participation in the meeting.

11. **Forced disconnections.** The chair may order the Recording Secretary, or assistant, to disconnect or mute a member's connection if it is causing undue interference with the meeting. The chair's decision to do so, which is subject to an undebatable appeal that can be made by any member, shall be announced during the meeting and recorded in the minutes.

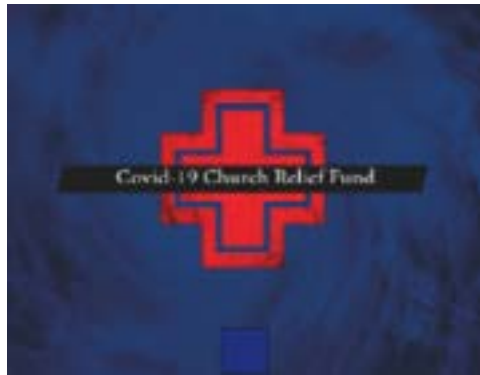
