To those who knew Nancy was having hip replacement surgery, she is doing great! Thank you for your prayers, cards, phone calls and inquiries.

Too often we forget about the people who came before us. We do not know how church buildings were built or who paid the bills; we assume the current congregation paid for it all. In Alaska, I know of few churches who have not received help from the Alaska Baptist Convention, the North American Mission Board (NAMB), the 2000 Club and the Valeria Sherard State Mission Offering. As I think about literacy work and disaster relief efforts (including the "Buckets of Hope" in Haiti) I realize they all have roots in Alaska. When John and Lillian Isaacs went to Fairbanks in the 1960s, part of their assignment was to teach English as a Second Language (ESL). They were so successful and Lillian was such a master storyteller, literacy work exploded across the Sourthern Baptist Convention. The small group/classroom concept was developed out of necessity at Friendship Baptist Church in Fairbanks and at least six language churches in Alaska are the result of that literacy work.

In August 1967 the annual meeting of the Alaska Baptist Convention was scheduled to meet in Fairbanks. Home Mission Board (now NAMB) representatives were to attend, along with the Director of the Brotherhood Commission. When word came that Fairbanks had flooded, the Convention meeting was canceled and telephone calls were made for help. Winter was coming. Airlines that serviced Fairbanks at that time donated planes to carry construction teams to help repair damage. As a result of the flood, discussions began in earnest about mobilizing response teams. Today, Southern Baptist Disaster Relief is the third largest disaster response organization in the world.

With the arrival of John Forrester to First Baptist Church, Kotzebue, and Brenda Crim, Baptist Collegiate Ministries, University of Alaska Anchorage, the idea of "Bible in a Bucket" was born and has been used annually in Nome during the Iditarod Sled Dog Race and in Kotzebue during their July 4 celebration. The bucket contains a Bible and other Christian materials. "Buckets of Hope" started during the Haitian relief effort, has food, a Bible and other material and is a spinoff of Alaska's "Bible in a Bucket."

As I reflect on these and other ministries, I realize every one of them has a common thread – the Cooperative Mission Program. The Isaacs, Forresters and Brenda are appointed missionaries supported through Cooperative Program and NAMB. Disaster Relief is supported through the Cooperative Mission Program and the North American Mission Offering. I am so thankful that in Alaska, even though we are small in numbers, we can be part of ministries that impact the cause of Christ all over the world. Thank you for supporting missions through the Cooperative Program and the direct mission offerings. Remain faithful doing what you can, where you are, using what you have, to the glory of God.

As a new church year begins, we will start the process of switching from one calendar to the next for the purpose of filling out our Annual Church Profiles (ACP). Is this record-keeping system one of those things in ministry that we see as a nuisance, or non-negotiable to our work? How many of us keep records? How many of us like statistics? Why do we keep those numbers and what do they represent? They represent lives, souls, people and hearts. They reflect whether or not our churches are reaching more people for Christ or if we have the same number of people in our churches as we did a year ago. I am sure every pastor looks at his church budget; ACP numbers are just as important and I take them very seriously.

When God is blessing a ministry, part of that blessing is an increase in attendance. But here is a problem I have encountered when speaking to church members, and I need some help understanding it. Pastors, how do you answer members who say things like "I really like the church the way it is now" or "I like the fact that I know everyone in my church" or "If our church gets any larger, I am going to have to find a small church to attend."? I heard these types of comments when I was a pastor and I have heard the same thing from church members today. Increased attendance is a threat to those who make these statements. Pastor, how do you help these folks see the selfish side of their comments? Please call or write to let me know the strategies you use to help people see beyond themselves. I wonder if the lack of growth in churches comes from within the church, and the complacency we see is the result of wrong motives and lack of love for the lost and needy? Recently, someone made a simple statement that gave me pause. They said "not everyone wants to go to a megachurch." There is great truth to that and one we must understand in the climate of the Alaska Baptist Convention. There has always been a tendency to promote success of the "megachurch." The implication is that the small church cannot be successful but we all know some Alaskan cities could not sustain a "mega-church." It is hard to have a "mega" anything when there are less than 500 people in town.

What is the definition of a successful church? Biblically, the most successful church is one that encompasses the functions of prayer, worship, ministry, community, evangelism and discipleship. That's why we need to keep ACP statistics to gauge if we are maintaining or growing our church membership. The bottom line is, are we making disciples in our churches and in our communities? Have the activities of your church resulted in members who exhibit the characteristics of a disciple of Christ? If you need help with this, give me a call. I would love to talk with you about establishing a great disciple-making plan.

A vision is not a dream, and not a plan on how to achieve anything. A vision is what you see as your "promised land." The mountain climber stands on the slope and peers into the sky at the distant peak; that's where he's headed. It's his vision. The pastor sees a congregation saturating the community with ministry and service and witness. That is his vision. A businessman knows exactly the kind of company he is setting out to build. The maestro begins assembling musicians with a definite idea in mind as to the kind of symphony he is creating. The chef prepares a feast for a wedding party. An engineer draws a picture of the bridge which will span the river. Each has a vision.

If you plan to lead, it might be a good idea to know where you're going. The folks coming along behind you would like to know where you plan to take them. That concept, that goal, that's your vision. Your vision is the answer to the question: when you get where you are going, what will it look like?

"Some men see things as they are and ask why; I see things that never were and ask why not." That memorable line, often attributed to Robert F. Kennedy, actually belongs to the playwright, George Bernard Shaw from his "Back to Methuselah." The mixup resulted from Senator Ted Kennedy's quoting it about President Kennedy at his funeral in 1968.

It's a great line. It's reminiscent of something from the 11th chapter of Hebrews. "By faith we understand that the universe was formed at God's command, so that what is seen was not made out of what was visible." (11:3)

There are those who see things no one else sees, who hear music unheard by the human ear, who know things not revealed in the physical world. These are people of a faith-vision.

The writer of Hebrews gives numerous instances of people with faith-vision which enabled them to see what God wanted them to do, where He wanted them to go, how He wished them to live. One example is Moses. "By faith (Moses) left Egypt, not fearing the wrath of the king, for he endured, as seeing Him who is unseen." People of faith see things otherwise unseen. Faith-vision.

A vision is not about leadership. It comes before leadership. One can have a vision but no leadership, but real leadership requires a vision. As you are called to lead you must answer the question, "What is my vision?"
