Good Counsel: 4 rules that reduce pastoral counseling risk

Many pastors consider counseling ministries an extension of their calling, providing much-needed support for members. But those ministries can introduce something else: **risk**.

"As much as pastors want to trust those they counsel, it's Biblical that they are at risk as they answer their

calling," says Gaelen Cole, Property and Casualty program manager for GuideStone Agency Services. "1 Peter 5:8 speaks of this explicitly. Being alert and of sober mind are the best ways to prepare for the possibility that things may go awry in the counseling relationship."

4 RULES TO REDUCE YOUR RISK

Rule #1: Make it official

"From risk management and liability perspectives, it's very important that ministries consult with a qualified attorney and put their counseling procedures in writing," says Cole. Any staff, including the pastor, who provides counseling should be trained on these procedures. It's also important to obtain signed consent forms before sessions begin.

Rule #2: Understand your liability

"When it comes to counseling, probably the most important concept churches need to understand is **negligence**," says Cole.

"When a pastor enters into a counseling relationship, he assumes a duty owed to the counselee. Failure to meet this implied duty can lead to accusations of negligence and claims of emotional injury. Counselees may be awarded damages for which the church can be liable. This concept applies in all states and presents a huge risk for counseling ministries. That's why understanding your liability is so important." Churches' general liability policies exclude professional liability of this sort – so churches should make sure they have **dedicated liability coverage specifically designed** **for counseling ministries**. Be sure to talk to your agent to make sure your specific situation is covered appropriately.

Rule #3: Know your state law

Each state has specific laws and statutes that apply to

counseling activities, requirements, licensing and liability. "Each church must understand their state's specific laws, or they could unknowingly be courting danger," says Cole.

Child or elder abuse reporting requirements

Allegations of child or elder abuse can surface during counseling sessions. In most states, licensed and lay counselors are required to report this information to authorities or be vulnerable to lawsuits. From a liability perspective, pastor-member privilege may exempt the pastor from reporting information disclosed during "privileged" conversations. However, this privilege has specific limits that vary state to state. This is why it's important to get the advice of a qualified attorney.

Confidentiality

Your church bears the burden of keeping good records – and keeping private information secure. Have documented policies in place dealing with all forms of data: electronic, hard copy, recording, video or

even verbal. Remember: Should confidential information be disclosed – whether purposefully or inadvertently – the client may be able to sue both the pastor and/or the church. Applicable statutes vary by state.

Licensing and therapeutic practices

In most states, only licensed individuals may refer to themselves as "counselors." Pastors who counsel are exempt from this restriction, but lay counselors are not. Non-licensed pastoral counselors should make it

clear they are providing spiritual-based counseling, not engaging in other treatment practices such as psychotherapy or psychology, which fall under state licensing requirements.


Rule #4: Set boundaries

Counseling presents particular dangers for pastors: it's necessarily intimate, emotional and personal. Balancing an open, supportive approach with safeguards to protect both parties can be a challenge. Sensible boundaries are paramount.

- **KEEP AN "OPEN DOOR" POLICY.** Conduct counseling sessions during normal hours, visible to other staff in the building.
- ENFORCE THE THIRD-PARTY RULE. Avoid oneon-one "mixed gender" (male/female) counseling whenever possible. If you can't avoid it, make sure there's a third person in the room or that sessions only take place on church property within clear view of staff.
- AVOID "TRANSFERENCE." This is one of counseling's biggest dangers. Simply put, "transference" happens when the client "transfers" intense emotion felt for another figure (parent, spouse, etc.) to the counselor, creating a powerful sense of dependence and intimacy that can drive inappropriate conduct. Be sure you're educated about the dangers of transference and implement strategies to avoid it.
- TAKE SAFETY PRECAUTIONS. Those who seek counseling may be in difficult marriage situations, facing domestic violence, struggling with dark feelings or dealing with other issues that may bring danger to the church's doors. Make sure your church is protected should clients pose a danger to themselves or others.

"Your property and liability insurance agent should be knowledgeable on these topics," says Cole. Review your policy and risk management strategies with your insurance agent to be fully informed.

Snapple's Real Facts #813 identifies the "#" symbol as an "octothorpe." I have always referred to it as the number sign; more recently, it is referred to as a "hash tag." I have been told all three definitions are correct depending on how the symbol is being used. In the world of tweets, it is a hash tag; in the world of numbers, it is a number sign; and according to the dictionary, it is an octothorpe. One symbol, three different uses, three different definitions.

Isaiah 9:6 says, "For a child is born to us, a son is given to us. And the government will rest on his shoulders. These will be his royal titles: Wonderful Counselor, Mighty God, Everlasting Father, and Prince of Peace." (New Living Translation) – one person and four different titles. This passage refers to Jesus Christ, and each title speaks to a different aspect of His identity. These are not the only titles for Jesus found in the Bible; He is also called the Word of God; the Lamb of God; the Bread of Life; the Good Shepherd; the Great Physician; the Door; the Alpha and Omega; the King of kings and Lord of lords, and many others. Each title and name indicates that Jesus Christ is able to meet every need we have, may have or ever will have.

Recently, an acquaintance was listening to a self-improvement tape produced by one of the many self-improvement counselors. The lecturer said things like, "you are what you think", "think positive and positive will happen" and "you determine your own destiny." After the tape was over, I asked where the lecturer received such insights and was told it was from years and years of meditation, study and self awareness. I mentioned everything the person talked about was in the Bible, and my acquaintance got very defensive and denied that anything like it could be in the Bible because the Bible is outdated and not relevant today. They asked me to show them, so I did: "you are what you think" is a rephrasing of Proverbs 23:7, "For as he thinks in his heart, so is he"; "think positive and positive will happen" comes from Philippians 4:8-9, "Fix your thoughts on what is true and honorable and right. Think about things that are pure, lovely and admirable. Think about things that are excellent and worthy of praise. Keep putting into practice all learned...and the God of peace will be with you"; "you determine your own destiny" is found in Proverbs 14:12 and Proverbs 16:25, which say "there is a way which seems right to a man..." As I addressed the other principles the self-help guru taught, I mentioned the one main teaching he did not present was a person's need for Jesus Christ and that Jesus Christ is truly "the Way, the Truth and the Life and that no one can come to the Father (get into heaven) but through Him" John 14:6. I wish I could tell you my friend became a believer in Jesus Christ but he did not. We parted company with the promise he would think about it, but he was still convinced that while some of the Bible might be true, not all of it is.

I may be considered old-fashioned but I believe all of the Bible is true and relevant today and as we study it, and apply the teachings to our lives, God will meet our every need for He is our Wonderful Counselor, Mighty God, Everlasting Father and Prince of Peace.

Proverbs 16:3 says: "Commit to the Lord whatever you do and your plans will succeed. "(NIV, 1984) This is not a "name it and claim it" promise. Two words in this passage stand out to me - 'commit' and 'plans.' The intent is to submit to the Lord our ideas of activities to honor God. The second word is plans. In planning, the idea of intentionality is the emphasis. What are we doing to honor God? What plans do you have for your church this year in terms of ministry, evangelism and discipleship? Our current emphasis of God's Plan for Sharing (GPS) is "Season of Service." Many of our churches are currently serving their communities. In Anchorage, the Luis Palau Family Festival (June 7-8) will have a major emphasis on a "Season of Service." A committee has been formed to seek ways to serve the community in the area of need. There is an opportunity for your church to be involved. Call me for more information.

Why not try something new in your church this year? Bob Mayfield is the state Sunday School Director for Oklahoma and following is an excerpt from a letter I received:

"As you know, Oklahoma has been asking churches to officially commit to start new groups this past year (2013). We asked them to complete a commitment card that includes the number of groups they plan to start in 2013. We have been collecting commitment cards since last February and I have **discovered a ratio of new groups/church that has been consistent all year**.

In Oklahoma, we are **averaging three (3) new group starts per church**. For 2013, we are going to finish with 245 churches that officially partnered with us, and they committed to 711 new groups. That is an average of 2.9 new groups/church. I believe that this ratio is similar to our "Principle of 10" of increasing attendance by 10 for every new group the church starts.

We have commitments from our largest churches, and from our smallest churches. We have ethnic churches, urban churches, suburban churches, and cowboy churches that have made commitments. We have churches of all sizes and styles make commitments, and the average has consistently been three new groups per church all year."

What plans will you commit to the Lord this year? I hope this prompts you to be proactive in reaching and ministering to the lost in your community. Call me if you have questions or want guidance. Bless you as you seek to advance God's kingdom in 2014.

In Luke 17:7-9 we read, "But who is there of you, having a servant plowing or keeping sheep, that will say unto him, when he is come in from the field, Come straightway and sit down to meat; and will not rather say unto him, Make ready wherewith I may sup, and gird thyself, and serve me, till I have eaten and drunken; and afterward thou shalt eat and drink? Doth he thank the servant because he did the things that were commanded?" And then he adds something that we really struggle with, "So likewise ye, when ye shall have done all those things which are commanded you, say, We are unprofitable servants: we have done that which was our duty to do." Luke 17:10

As a follower of Jesus, there is no "above and beyond the call of duty." But let me encourage you: Jesus will never ask us to do more than He would do. And although He may be a hard taskmaster, there is not one thing He requires that He does not assist us in doing. Besides, the Bible tells us we have an eternity to rest. Hebrews 4:9, "There remaineth therefore a rest to the people of God."
